**I. The meeting was called to order by President Kelly Dix (Pottawattamie) at 5:00 PM.**

4. Junior Naturalist- Diane Hall explained the Junior Naturalist program for those that were not aware of it and mentioned that Joel Van Roekel should be contacted for patches.
5. Joe Halbur Scholarship- Lora Kanning mentioned the March 14 deadline. She also mentioned that the committee will be discussing the possibility of making a \$150 scholarship available for past winners.
6. Scholarships- Jessica Steines reported that NAI scholarships are available for up to a \$100 reimbursement. They will also be updating the application.
7. Membership- Logan Roberts (Warren) reported that membership is at 135 people. She asked that members send in their picture for the membership list.
8. IAN Mentoring Program- Heather Hucka (Story) explained the mentoring program and asked for new naturalists to contact her for more information.
9. IAN Website- Cari Nicely (Henry) explained that there was an IT problem with the IAN website and that it had been fixed. She mentioned that committee leaders need to inform her of new information that needs to be changed or added to the website and to explain precisely where it needs to be in order to operate efficiently.
10. Traveling Exhibits- Ann Burns (Jackson) reported that the IAN travelling prairie exhibit is still travelling around the state and has been since 2010. She also mentioned that the committee is looking for new members to help finish the “Wade into your Watershed” exhibit. She also reported that part of the National Mississippi River Museums turtle exhibit is available by contacting the NMRM and that there are exhibits available for swapping on the IAN website.
11. REAP Alliance Liaison- Logan Roberts reported that the environmental lobby day is coming up the week following the Spring 2014 IAN workshop and that they would be looking for \$25 million in funding for REAP on its 25<sup>th</sup> anniversary.

4. IACCBE Rep.- Christina Roelofs (Shelby/Audubon) reported that Winterfest planning meetings are ongoing and ideas are welcomed for keynote presenters.

**VII. Action/Discussion Items (5 minutes each)**

1. "Water Quality and Biological Diversity in Stormwater Wetlands: Enhancing Environmental Knowledge and Stewardship in Urban Areas" Project Discussion by Rebecca Christoffel

Christoffel (ISU) mentioned that there may be grant funding available to help naturalists and teachers work on monitoring urban wetlands (to test water and biodiversity). Past data will be compared and they will find out in April if funding is available. It would start in Polk and Story Counties before moving to other counties.

2. NAI Sponsorship- Victoria DeVos (Plymouth) asked if IAN would be willing to be a sponsor for the NAI Regional Workshop in Ames in the Spring of 2015. She listed off benefits of being a sponsor such as advertisements and acknowledgement in their program and a link via

website. Karen Phelps (Benton) motioned for IAN to put forth a \$1000 sponsorship, seconded by Miriam Patton (Palo Alto), carried.
