Evaluations: Perform Evaluations as required by REAP grant. A pre and post test and/or other evaluation tools will be made available to the borrowing organization.

Indemnity: The Borrower shall indemnify and hold harmless **NMRMA** against any and all claims, actions, suits, proceedings costs, expenses, damages, and liabilities, including attorney's fees and costs, arising out of, connected with, or resulting from this agreement, exhibit, or the equipment including without limitation, the manufacture, selections, delivery, possession, use, operation, or return of the equipment or exhibit.

Title/Ownership: The exhibit equipment and design is the sole and exclusive property of **NMRMA**, and the Borrower shall have no right, title, interest, or copyright therein, except as set forth by this agreement. Borrower has no right to purchase or otherwise acquire title to or ownership of any of the equipment, exhibit, property or design of this agreement no matter that any part thereof may now be or hereafter become, attached or affixed to real property or any improvements thereon. The Borrower shall not assign this agreement to another party or physically transfer any property of this agreement to another entity or location not specified herein.

This agreement constitutes the entire agreement between **NMRMA** and the Borrower. No modification of this agreement shall be effective unless in writing and executed by both **NMRMA** and the Borrower.
